The Tax Dodging Bill Campaign

Let's make tax fair

e all pay our taxes, but large companies such as Amazon, Google and Starbucks seem to get away without paying their fair share.

Developing countries across the world lose out of an estimated \$160 billion a year as a result of corporate tax dodging.

However, all hope is not lost. There is something we can do about it.

Actionaid, Christian Aid, Oxfam and numerous other social action charities are all calling for the next government to tackle corporate tax dodging, and to make tax fair for everyone. It proposes the introduction of a **Tax Dodging Bill** specifically aimed at preventing big corporations from tax dodging, and making UK tax a fairer system.

Were a Tax Dodging Bill to be put in place, it could potentially generate billions of pounds for developing countries and a level playing field for the responsible companies already paying their fair share of taxes.

The Bill proposes that the law be changed to:

- Make it harder for big companies to dodge UK taxes, ensuring that they're not getting unfair tax breaks.
- 2. Ensure UK tax rules don't encourage big companies to avoid paying the correct

- amount of taxes in developing countries.
- 3. Make the UK tax regime more transparent and tougher on tax dodging.

Joint Churches look into the harmful role of Benefit Sanctions in the UK

n 2014, over one million benefit sanctions were imposed on people in the UK.

A sanction means that benefits are stopped for a period of time between one month and three years. The most common reason for being sanctioned is being late to a meeting or not turning up for an appointment.

A report undertaken by Church Action on Poverty, the Baptist Union of Great Britain, the United Reformed Church, the Methodist Church, the Church of Scotland and the Church in Wales has made many shocking discoveries on the issue, including:

- Over 100 people assessed as unfit for work due to mental health problems are being sanctioned each day.
- Approximately 100,00 children were affected by sanctions in 2013/14.
- Almost 7 million weeks of sanctions were imposed in 2013/14, compared to around 1.5 million in the previous year (an increase of almost 500%).

The report concludes that they believe there is an urgent need to re-think sanctions and recommend: A full review of the impact and efficacy of the sanctions and conditionality regime;

- A revision of the hardship payments system to avoid the deliberate imposition of hunger;
- For sanctions to be suspended for people with children and for those experiencing mental ill health:
