Key note speaker Sally Rush

Sally invited Synod to consider some of the parables in a new way as discussed in "The parables" by Paula Goodyear.

The focus was on two ways Jesus described the Kingdom of God.

 we were reminded that the quantities of flour described was enough to make bread for 100 people. So the women was baking for her community
- The kingdom of God is like a mustard seed. we were reminded that there are different types of mustard plants, one of which when planted will spread everywhere.

Synod was challenged to discuss which issues were most important to our local community and what matters to us personally.

Christians Against Poverty discussed with Sally how they partner with Churches. Synod was encouraged to think about who we are already partnered with to effect change in our local communities and which other organisations could we partner with.

Synod was also challenged to think about the rooms of influence we have access to, which other rooms might it be useful for local churches to gain access to and who should be invited.

DAF – How DAF grants have enabled Mission & Ministry Locally
